**AN ORDINANCE OF THE BOROUGH OF CAMP HILL, CUMBERLAND  
COUNTY, PENNSYLVANIA, AMENDING CHAPTER 190 OF THE CODE  
OF THE BOROUGH OF CAMP HILL, “VEHICLES AND TRAFFIC,” BY  
ESTABLISHING A SPECIAL PURPOSE PARKING ZONE ON  
SOUTH 15TH STREET**

**WHEREAS**, the Borough Council of the Borough of Camp Hill (the “Borough”), by virtue of the Laws and Constitution of the Commonwealth of Pennsylvania, including the provisions of the Act of 1976, June 17, P.L. 162, No. 81, Section 101, et seq. (75 Pa.C.S.A. § 101, et seq.), as the same may be hereinafter amended, is empowered to establish parking regulations upon Borough highways and bridges; and

**WHEREAS**, the Section 1202(5) of the Borough Code empowers the Borough to provide for the health, morals, general welfare, convenience, comfort, and safety of the citizens of the Borough; and

**WHEREAS**, Section 6109 of the Pennsylvania Vehicle Code, 75 Pa.C.S. § 6109, authorizes municipalities to regulate the parking of vehicles by a duly enacted ordinance; and

**WHEREAS**, Section 3354(d)(2) of the Pennsylvania Vehicle Code, 75 Pa.C.S. § 3354(d)(2), authorizes municipalities to reserve handicapped parking areas for use by persons with a disability or whom is a severely disabled veteran; and

**WHEREAS**, the Borough Council, deems it to be in the best interest of the Borough residents to amend the Code of the Borough of Camp Hill (the “Code”) relating to special purpose parking zones, in order to limit access to handicapped parking only in designated areas as set forth herein.

**NOW, THEREFORE, BE IT ENACTED AND ORDAINED**, by the Borough Council of the Borough of Camp Hill, Cumberland County, Pennsylvania, as follows:

**SECTION 1: ESTABLISHMENT OF A STOP INTERSECTION.**

The Borough Council has determined that parking vehicles on highways under the jurisdiction of the Borough may be regulated by special purpose parking zones. As such, a special purpose parking zone shall be located on the eastern side of South 15<sup>th</sup> Street, at 209 South 15<sup>th</sup> Street, Camp Hill, Pa 17011.

**SECTION 2: AMENDMENT TO THE VEHICLE AND TRAFFIC ORDINANCE.**

Chapter 190 of the Code of the Borough of Camp Hill is hereby amended in the following respects (All references to section numbers are sections from the existing Chapter 190 of the Code of the Borough of Camp Hill “Vehicles and Traffic”):

*Section 190-17 Special purpose parking zones* is amended by adding the following parking zone to the list of areas located in the Borough and declared to be a handicapped parking zone:

**SECTION 3: SEVERABILITY.**

If any provision, section, sentence, clause or portion of this ordinance shall be held invalid or unconstitutional by any court of competent jurisdiction, such invalidity or unconstitutionality shall not affect any other provision, section, sentence, clause or portion of this ordinance which shall continue and remain in full force and effect.

**SECTION 4: REPEAL OF PRIOR INCONSISTENT ORDINANCES.**

All prior ordinances or parts of ordinances inconsistent herewith are hereby repealed. Except as expressly amended hereby, nothing herein shall be deemed to affect or alter the provisions of Chapter 190 of the Borough Code of Ordinances.

**SECTION 5: EFFECTIVE DATE.**

This ordinance shall become effective immediately.
