Bids for the construction of the Project will be received by the Borough of Camp Hill, online, until Wednesday, September 23, 2020 at 1:00 PM local time. At that time the Bids received will be publicly opened and read.

The Project includes the following Work:

The completion of one (1) spot repair of 8-inch sanitary sewer main and lateral reconstructions; cured-in-place lining of approximately 4,800 feet of 6-inch to 10-inch sanitary sewer main and lateral reinstatements; replacement of one (1) sanitary sewer manhole; rehabilitation of 21 sanitary sewer manholes; associated demolition work; surface restoration; and all other work identified in the Contract Documents.
