NOTICE IS GIVEN that the Council of the Borough of Camp Hill, in Cumberland County, Pennsylvania (the "Borough"), proposes to enact, at a public meeting to be held not less than three (3) days nor more than thirty (30) days following the date of publication of this notice, an ordinance (the "Ordinance"), the caption and summary of such proposed Ordinance being as follows:

#### "AN ORDINANCE

**AUTHORIZING AND SECURING THE ISSUANCE OF ONE OR MORE SERIES OF GENERAL OBLIGATION BONDS IN THE MAXIMUM AGGREGATE PRINCIPAL AMOUNT OF \$13,000,000, PURSUANT TO THE PENNSYLVANIA LOCAL GOVERNMENT UNIT DEBT ACT, TO CURRENTLY REFUND THIS BOROUGH'S OUTSTANDING GENERAL OBLIGATION BONDS, SERIES OF 2015 AND A PORTION OF THIS BOROUGH'S OUTSTANDING GENERAL OBLIGATION BONDS, SERIES OF 2012 AND TO PAY RELATED COSTS; ACCEPTING A BOND PURCHASE AGREEMENT; SETTING FORTH THE PARAMETERS, SUBSTANTIAL FORM OF AND CONDITIONS FOR ISSUING THE BONDS; PLEDGING THE FULL FAITH, CREDIT AND TAXING POWER OF THIS BOROUGH TO SECURE THE BONDS; CREATING A SINKING FUND AND APPOINTING A PAYING AGENT AND SINKING FUND DEPOSITORY; APPROVING RELATED DOCUMENTS AND ACTS; AND AUTHORIZING RELATED ACTION."**

The full text of the Ordinance may be examined by any citizen, in the Borough Administration Building, located at 2145 Walnut Street, Camp Hill, Pennsylvania, on Monday through Friday between the hours of 8:00 a.m. and 4:30 p.m.

The Ordinance available for inspection may be amended prior to its final enactment as permitted by the Pennsylvania Local Government Unit Debt Act (the "Debt Act"). An advertisement of the final enactment of the Ordinance, including a description of any amendments, will be made in accordance with the Debt Act. This Notice is given in accordance with the Debt Act.
