

ORDINANCE NO. 2018-03

AN ORDINANCE OF THE BOROUGH OF CAMP HILL, CUMBERLAND COUNTY, PENNSYLVANIA, VACATING PORTION OF OLIVE ALLEY.

WHEREAS, on July 25, 2018, the Borough received a Petition to Vacate a Street ("Petition"), pursuant to 8 Pa. C.S. § 1732, requesting to vacate a portion of Olive Alley extending between North 26th Street and King Alley, as depicted in the Petition and in the attached Camp Hill Borough Plan of Lots, District 3, Section 23, from all landowners abutting said portion, specifically, Brian J. and Kendra M. Hinkle, who reside at 237 N. 26th St., and James D. Kreider and Molly H. Dougherty (h/w), who reside at 233 N. 26th St. (collectively "Petitioners"); and

WHEREAS, said portion of Olive Alley has never been accepted as a public street;

WHEREAS, on September 12, 2018, the Borough Council conducted a duly advertised public hearing; and

WHEREAS, Petitioners have agreed to submit an amended Petition within 10 days to release the Borough from damages sustained as a result of the vacation from any landowner abutting the said portion of Olive Alley, and any nonabutting landowners who may have any private interest in said portion of Olive Alley.

NOW, THEREFORE, BE IT ORDAINED AND ENACTED by the Borough Council of the Borough of Camp Hill, Cumberland County, Pennsylvania, that:

Section 1. Said Petition, subject to the aforementioned Amendment, is GRANTED. The portion of "Olive Alley" extending between North 26th Street and King Ally, as depicted in the Petition and the Attached Camp Hill Borough Plan of Lots, District 3, Section 23, is VACATED.

Section 2. Repealer. All ordinances or resolutions or parts thereof, insofar as they are inconsistent herewith, shall be and the same are hereby repealed.


Section 3. Effective Date. This Ordinance shall become effective immediately upon the date of its enactment.



TO THE BOROUGH COUNCIL OF THE BOROUGH OF CAMP HILL:




WHEREFORE, the undersigned Petitioners hereby pray the Borough Council grant the Petition, as amended.




