**AN ORDINANCE OF THE BOROUGH OF CAMP HILL,
CUMBERLAND COUNTY, PENNSYLVANIA, AMENDING CHAPTER
190 – “VEHICLES AND TRAFFIC” OF THE CAMP HILL BOROUGH
CODE TO ADD STOP INTERSECTION LOCATIONS AT SPECIFIED
LOCATIONS**

WHEREAS, the Borough Code, 8 Pa.C.S. §§ 101, *et seq.*, requires Camp Hill Borough (“Borough”) to adopt ordinances for legislation that exercises the Borough’s police power; and

WHEREAS, traffic and parking regulations have been held to be a valid exercise of police powers in the Commonwealth of Pennsylvania; and

WHEREAS, the Camp Hill Borough Code, Chapter 190 “Vehicles and Traffic,” Section 190-2 prescribes in relevant part that all traffic and parking regulations of a permanent nature be enacted as amendments to ordinances of the Camp Hill Borough Code; and

WHEREAS, the Council desires to further amend the Borough’s Chapter 190 traffic regulations to further promote health, safety, and welfare in the Borough.

BE IT HEREBY ENACTED AND ORDAINED by the Borough Council of the Borough of Camp Hill, Cumberland County, Pennsylvania, as follows:

Section 1. Chapter 190 – “Vehicles and Traffic” of the Camp Hill Borough Code is hereby amended in the following respects (All references to section numbers are sections from the existing chapter).

A. Section 190-11, “Stop intersections.” is amended under subparagraph “A” to incorporate the following locations in alphabetical order to be included as stop intersections with official stop signs erected as indicated:

South 36th Street	South	March Drive
Circle Place	North	Beverly Road
June Drive	South	March Drive
Maple Road	West	30th Street

North 28th Street	South	Lincoln Street
October Drive	North	September Drive
October Drive	South	April Drive
September Drive	West	April Drive
September Drive	East	May Drive
Westerly Road	South	North 31st Street
Beverly Road	West	North 30th Street
Beverly Road	East	North 29th Street
Willow Avenue	South	Logan Street

Section 2. All ordinances or parts thereof inconsistent with the provisions of this Ordinance including, the previously adopted Chapter 190 – “Vehicles and Traffic,” are hereby repealed.

Section 3. The provisions of this Ordinance are declared to be severable. If any provision of this Ordinance is declared by a court of competent jurisdiction to be invalid or unconstitutional, such determination shall have no effect on the remaining provisions of this Ordinance.

Section 4. This Ordinance shall be effective immediately following its legal enactment.
